# TOGETHER FOR STRONGER FUTURES

Dear Family Law CASA Community Members,

We are so pleased to have wrapped up another successful fiscal year of serving kids at Family Law CASA. With your support, in partnership with our staff and volunteers, we were able to enable bright futures for over 180 children in 120 cases this past year!

This past fall, we held a 20th anniversary event inviting members of the Family Law CASA community to join in the festivities as we celebrated advocating for over 3,000 low-income children. This spring, the Family Law CASA staff and board carefully considered our organization's strengths, challenges and opportunities and laid a course forward over the next three years to respond to community needs, strengthen our organization, deliver high-quality programming, and begin to plan for our 20-year vision.

We are also proud to report that this year we raised our income limits for the families we serve due to the continued increase in the cost of living in King County. The new income limit is \$128,160/year matching the Public Defenders Low-Income guidelines for two parents with one child. This income cap increase has given us the opportunity to offer our services to more families in need.

As the cases we work on have become more complex and more highly litigated, we have striven to equitably represent each child's voice, regardless of background, and ensure the highest quality recommendations to the King County

court. We continued training all of our staff, board and advocates on diversity, equity and inclusion and integrated best practices into our policies and practices towards our racial equity goals.

In alignment with our commitment to advancing racial equity and increasing access to justice for all, we expanded our program to include interpretive services for non-English speaking families. This past year Family Law CASA provided Court Appointed Special Advocates (CASAs) for nine non-English speaking cases – six Spanish, one Samoan, one Russian and one Japanese.

In this report, you will see the impact we collectively had, learn about new innovations in our programming, and read about our exciting 3-year strategic priorities that will lay the groundwork for a strong future.

We are ever grateful for all of the support and partnerships that help us do this important work to enable healthy kids and families and create a more equitable future for all in our community.



184

Family Law CASA provided an advocate for 184 children, giving them a voice in court and a safe custody plan.






Of the 184 children assigned an advocate, 64% of them were 11 years old or younger.



All of the children in Family Law CASA cases were from low-income households.



Family Law CASA reports and recommendations helped 27% of assigned families settle their case out of court avoiding trauma and saving the courts a substantial amount of time and resources.



## NINE






## 53 OUT OF 120

Family Law CASA managed a caseload of 120 cases, with 53 cases completed during the year.

#### RISK FACTORS IN CASES ASSIGNED TO FAMILY LAW CASA



The program team navigated tough and complicated cases this year, 90% of which involved allegations of domestic violence, 78% included substance abuse, 64% neglect and 50% mental health issues among other high-risk factors. Most cases involved more than one high-risk factor.

Of the 156 active advocates, 25% were BIPOC volunteers. BIPOC advocates are assigned to cases first, whenever possible.



6,360 hours were donated by volunteer advocates to support the cases assigned to Family Law CASA in King County Superior Court.

Two implicit bias trainings were held for new advocates, led by experienced mediator, attorney, and forensic evaluator, Darcia Tudor. Current advocates and contract attorneys also participated.



56% of families were from communities of color including 24% Black/African American, 15% Latinx/Hispanic,12% two or more races, 3.6% Asian/Pacific Islander, and 1.2% Native American/Indigenous.



Ninety-five advocates were assigned to cases in fiscal year 2023. Active advocates have experience and expertise in a wide variety of related backgrounds, including law, social work, education, mental health counseling, and child development.

50% of the families in Family Law CASA cases were not able to afford attorney representation and continued through court proceedings as pro-se litigants. Family Law CASA's program team assisted with administrative details for the court to ensure each child would have a final parenting plan looking out for their safety.



# PROGRAM HIGHLIGHTS

Family Law CASA is forever evolving to stay at the forefront of family law issues, serve the needs of the court and to be the best advocates we can be for the children in the middle of high-conflict custody cases.

### **Setting the Standard**

A key effort this past year was Family Law CASA's involvement in the development of the Intimate Partner Violence Impact Assessment (IPVIA) tool which helps identify the presence and impact of IPV in family law cases.

This is a collaborative project with the Coalition to End Gender Based Violence and the Justice for Families Committee and Family Law CASA has been involved for several years. In January of 2023 we piloted a specialized 2-day training with 10 advocates which covered how to use the IPVIA tool and write the accompanying report. Several CASAs are already actively using the tool and among the first to do so in the state.


The process includes comprehensive questions for the advocates to ask the parties in order to get the full spectrum of Domestic Violence (DV) including coercive control which is a newly adopted element of DV that is now in the WA state statutes. Of the cases assigned to

Family Law CASA, 90% of them in the past 12 months included allegations of intimate partner violence. Therefore, the tool is critical for the safety of children in King County.

The long-term goal is to make the IPVIA process the standard for screening DV throughout Washington State and then the country at large. The Family Law CASA team is proud to be an early adaptor of the new most effective forms of advocacy, especially when dealing with DV/inmate partner violence.

### **Enriching Learning, Elevating Advocacy**

Family Law CASA remains committed to dismantling the systems of oppression that impact children and families in our community. This year, the program team developed new trainings and refreshed some existing materials to facilitate high quality learning for CASA volunteers. Examples of in-service training opportunities included a group Q&A time with Judge Jean Rietschel, a retired Chief Family Law Judge and Family Law CASA Board Trustee, and Dr. Mollie Hughes provided an overview of parenting classes and specific quidance about when it is appropriate to include classes in recommendations to the court.

Designed specifically for Family Law CASA, Darcia Tudor, an experienced mediator, attorney, and forensic evaluator, facilitated two trainings about implicit bias for new advocates. The focus on implicit bias is critical to the program.

In the past 12 months, 56% of families involved in cases assigned to Family Law CASA were from communities of color. However, of the 156 active advocates, only 25% were BIPOC (Black, Indigenous, and People of Color) volunteers. While the program team builds the pool of available BIPOC volunteers, they assign BIPOC CASAs to cases first, whenever possible.






Furthermore, implicit bias is not restricted to any one domain. Implicit bias can surface in reports. The program team added relevant statutory language for

parenting plans (ex: RCW 26.09.187) and listed factors for consideration when conducting analysis of parenting functions and the best interest of the children. The necessity of referencing this language and factors stems from the accepted body of research demonstrating that children with established, bonded relationships with both parents have better outcomes as they mature.

At Family Law CASA, we exist in response to the family court system that disproportionately impacts BIPOC families. Therefore, these learning opportunities are vital to our child advocacy program, and truly, giving children an authentic voice in court.

## **FY2023 REVENUE**










## **FY2023 EXPENSES**
