


Of the 168 children assigned an advocate, 79% of them were 11 years old or younger.

51%

Over half of the families in Family Law CASA cases couldn't afford attorneys and represented themselves in court pro-se. Our program team assisted with court administration to ensure each child had a final parenting plan focused on their safety.




93% of the recommendations made by Family Law CASA were adopted by the court.



Family Law CASA reports and recommendations helped 29% of assigned families settle their case out of court - avoiding trauma and saving the courts a substantial amount of time and resources.



# RISK FACTORS IN CASES ASSIGNED TO FAMILY LAW CASA



The Program Team navigated tough and complicated cases this year, 90% of which involved allegations of domestic violence, 67% neglect, 66% included substance abuse, and 53% mental health issues among other high-risk factors. Most cases involved more than one high-risk factor.



#### 57 OUT OF 114

Family Law CASA managed a caseload of 114 cases, with 57 cases closed during the year.




## 4,910

4,910 hours were donated by volunteer advocates to support the cases assigned to Family Law CASA in King County Superior Court.



All of the children in Family Law CASA cases were from lowincome households.



Of the 133 active advocates, 25% were BIPOC volunteers. BIPOC advocates are assigned to cases first when possible.



56.6% of families were from communities of color including 15.48% Black/African American, 9.52% Latinx/Hispanic, 5.35% Asian/Pacific Islander, 25% two or more races, and 1.2% Native American/Indigenous.




### **REVENUE**

**TOTAL IN-KIND VOLUNTEER HOURS: \$197,744\*** 



### **EXPENSES**




**TOTAL EXPENSES: \$1,258,344**

- Core Mission Support refers to the essential infrastructure that enables Family Law CASA to effectively fulfill our mission and ensures sustainability for our child advocacy program.




## **ADVOCATING FOR AUSTIN**

Austin was a 12-year-old boy facing a turbulent home life. While he lived primarily with his mother, Austin came in contact with his father's excessive drinking and verbal abuse. His father's unpredictable behavior, often fueled by alcohol, led to further emotional distress and conflict.

Austin bravely shared his story with Peter, our dedicated advocate, recounting the aggressive incidents. Peter identified the father's dangerous mix of alcohol and mental health medication, recommending therapy to address these issues and improve his relationship with Austin.

In the end, the judge decided Austin should be able to choose his visitation times with his father. Throughout this case, Austin's resilience and our advocacy highlighted the importance of prioritizing a child's well-being. Family Law CASA remains committed to supporting children like Austin, ensuring their voices are heard.

#### DOING RIGHT BY RILEY

Riley was a 3-year-old boy caught in a difficult family situation. For nearly 18 months, Family Law CASA advocaed for him as his parents navigated complex issues stemming from their past struggles with substance abuse.

Riley's mother, in recovery and living in a sober home, accused his father of verbal abuse, financial control, and neglect. The father, a recovering alcoholic, had once placed Riley in severe danger by driving intoxicated with him in the car.

The CASA on the case was Lauren, who gathered extensive information, including CPS records and treatment histories. She documented the father's history of neglect and abuse from previous relationships, and highlighted the pattern of coercive control and emotional harm he inflicted on Riley's mother. Lauren's comprehensive report made a compelling case for a domestic violence (DV) restriction to protect Riley and his mother.

Despite the father's current sobriety, Lauren discovered his relapse and the potential dangers it posed to Riley. Her detailed, objective report led to a settlement where the father agreed to complete DV and substance abuse evaluations and treatment before expanding his visitation rights.

This case underscored the importance of thorough, empathetic advocacy in ensuring the safety and well-being of vulnerable children like Riley.

## **GIVING KIDS A PLATFORM**

This case centers around three children who were 16, 14, and 12 years of age. Their mother sought to modify their 50/50 parenting plan due to their father's alcohol use, which raised safety and emotional abuse concerns.

The CASA, Dave, interviewed the three children and their older sister, giving them a platform to voice their fears about their father's drinking. He also consulted their teachers and medical providers to ensure the children's best interests were prioritized. Dave recommended that the children be allowed to decide if they wanted to spend time with their father and suggested measures to reduce parental conflict.

Due to the compelling evidence in Dave's report, the case concluded with a settlement that prioritized the children's well-being. In a feedback survey, the mother in the case wrote, "Dave was very professional and never showed a sign of preference toward either parent. I appreciated his promptness, his organization, his care of the delicate situation and his wisdom. I appreciate you all very very much. Thank Dave for me."
